- The JCC requires a current driver's license or other valid photo ID for all persons applying for membership.
- I understand that regular searches of the National Sex Offender Public Registry (www.nsopr.gov) and/or the State of Maryland Sex Offender Registry (www.dpscs.state.md.us), (the Registries), will be conducted for all applicants and existing members. Any person identified in the Registries shall be denied membership to the Jewish Community Center of Greater Baltimore.

By my signature below, I release, hold harmless, and indemnify the Jewish Community Center of Greater Baltimore, as well as its agents and employees, from and against any liability on their part, of any kind whatsoever, which may arise in any manner whatsoever, from my use of the JCC's facilities. Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Jewish Community Center of Baltimore, Inc (the "JCC") has put in place preventative measures to reduce the spread of COVID-19; however, the JCC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the JCC could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the JCC and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the JCC may result from the actions, omissions, or negligence of myself and others, including, but not limited to, JCC employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with me and my child(ren)'s attendance at the JCC or participation in JCC programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the JCC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the JCC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any JCC program.

Member Code of Conduct Relating to Coronavirus/COVID-19

The JCC is committed to providing a safe and welcoming environment for all members, visitors, and staff. The Torah guides us: *Vinishmartem Mi'od Linafshotechem*, take vigilance in protecting yourself. In keeping with this important Jewish and universal value, we ask individuals to act appropriately at all times when they are on our campus or participating in our programs. We ask you to commit to abiding by the following practices and policies:

- Practice physical distancing. There is no congregating in groups on campus, in the fitness areas or after classes.
- Follow check in procedures and protocol as instructed. Please wait patiently with a minimum 6 feet distance with the person in front of you.
- Be prepared to sign a waiver, truthfully answer a few questions, and have temperature taken at check in.
- Wear a mask on campus and be considerate of others.
- Members must bring their own water. There will be no water stations available.
- Only members over the age of 13 will be allowed to utilize our pools, track, racquetball court and table tennis facilities. Members ages 13-15 must complete Jr. Weight training before using the Fitness Centers. Must be 16 or older to participate in Group Fitness.
- Everyone must sign up ahead of time for all all in-person and live-streamed virtual JCC activities.
- In the event inclement weather occurs while outside fitness members are outside taking a class, swimming or playing tennis, members will be instructed to head to their cars, there will be no congregating outside or under tents.
- The JCC, through its CEO and Board of Directors, reserves the right to remove from the premises any individual not abiding by these practices and policies or acting in an inappropriate manner and further reserves the right to cancel the membership of any such person.

I have read and understand this code of conduct. I agree to abide by the rules described above and understand I may be subject to removal if I violate any of these rules.

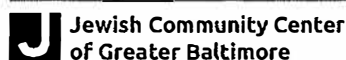

The JCC is committed to providing a safe and welcoming environment for all members, visitors and staff. The Torah guides us: *Vinishmartem Mi'od Linafshotechem*, take vigilance in protecting yourself. In keeping with this important Jewish and universal value, we ask individuals to act appropriately at all times when they are in our facility or participating in our programs and abide by the following policies:

1. You must apply for the membership category that is appropriate for your age and marital status. Membership is subject to revocation without refund if you do not qualify for the membership category for which you have applied.
2. All members are required to use the JCC swipe tag upon entrance to the buildings and to enter our Early Childhood Centers.
3. Children 10 years of age and younger at must be attended while in facility. Parents and Guardians must follow JCC protocols for signing children in and out of our programs.
4. Appropriate attire must be worn at all times. Shirts and shoes are required when inside the JCC.
5. Members are required to adhere to the posted schedules for usage of all our facilities including the gym, café, public areas, pools, fitness center, etc.
6. We expect persons using the JCC to behave in a mature and responsible way, and to respect the rights and dignity of other members, guests, visitors and staff.
7. Members shall report any suspicious or inappropriate behaviors to the JCC staff. JCC staff members are eager to be of assistance. Members & guests should not hesitate to notify a staff member if assistance is needed.
8. Members are not permitted to post flyers, posters and/or announcements on JCC bulletin boards.
9. Members will not engage in any of the following prohibited actions that include but are not limited to:
 - (a) Angry or vulgar language, including swearing, name-calling or shouting
 - (b) Physical contact with another person in any angry way or threatening way
 - (c) Any demonstration of sexual activity or sexual contact with another person
 - (d) Harassment or intimidation by words, gestures, body language or any menacing behavior
 - (e) Theft or behavior that results in destruction of property
 - (f) Carrying or concealing any weapons or devices or objects that may be perceived as weapons
 - (g) Smoking is not permitted in or outside the JCC
 - (h) Use or possessions of illegal chemicals or alcohol on JCC property, in JCC vehicles or at JCC sponsored programs
 - (i) Loitering is not permitted in or outside the JCC
 - (j) Any other conduct of an inappropriate, threatening or offensive nature
 - (k) The JCC reserves the right to suspend the Membership privileges without refund, of any Member, or to remove from the premises any Member, who aids or abets in the unauthorized entrance of a non-member
 - (l) Any activity that is a conflict of interest with services JCC provides, such as, personal training, athletic training, or swim lessons.

The JCC, through its Executive Director and Board of Directors, reserves the right to remove from the premises any individual acting in an inappropriate manner and further reserves the right to cancel the membership of any such person.

The JCC reserves the right to deny access or membership to any person who has been identified in the National Sex Offender Public Registry and /or the State of Maryland Sex Offender Registry.
